







Map 2 (F) Syria, (H) (b)Saudi Arabia (Red Sea coast), (I) Israel, (J) Lebanon (P) Libya










(H) (b) Saudi Arabia (Red Sea coast) excluding transits This exclusion shall not apply where the vessels or craft are transiting the water claimed by Saudi Arabia as the territorial waters as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer cargo, stores, personnel

This exclusion shall not apply where the vessels or craft are transiting the water claimed by Yemen as the territorial waters as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer cargo, stores, personnel or the like.



Lake Maracaibo (N) Venezuela (N) Venezuela including all offshore installations located within its Exclusive Economic Zone, which is deemed to extend 200 nautical miles from the coast of mainland Venezuela. But this area: (i) shall not include any installations in the above area which are in the territorial waters, out to 12 nautical miles, of Islands, Dependencies or Countries which (Y) Guyana are not owned by Venezuela. (ii) shall not apply where the vessels or craft transiting Venezuelan waters as (Y) Guyana long as Calls to Offshore Installations whilst transiting, such vessels or craft shall not call at any port or place or in the Guyanese EEZ beyond interrupt territorial waters only. their passage to engage in the transfer of cargo, stores, personnel or the like. · It is understood and agreed that the vessel calls to Venezuela other than Lake Maracaibo & Gulf of Venezuela South of 11° North without giving notice of the voyage (except for B&T). However, this dispensation may be cancelled by insurer with 3 working days notice.
