


The Map of the Listed Areas of War Risk Navigation Limitations



Map 1 (A) Nigeria, (B) Benin, (C) Togo, (D) Gulf of Guinea




Map 2 (F) Syria, (H) (b) Saudi Arabia (Red Sea coast), (I) Israel, (J) Lebanon

(H) (b) Saudi Arabia (Red Sea coast) excluding transits
This exclusion shall not apply where the vessels or craft are transiting the water claimed by Saudi Arabia as their territorial waters, as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer cargo, stores, personnel or the like.

(M)(i) : Indian Ocean, Gulf of Aden and Southern Red Sea in respect of above detailed waters south of 18°N and north of 10°48'N

(M)(ii) : Indian Ocean, Gulf of Aden and Southern Red Sea in respect of above detailed waters south of 10°48'N

(a) On the northwest, by the Red Sea, south of Latitude 18°N;

(b) on the northeast, from Pakistan coastline at 25°19.250'N, 65°E;

(c) on the east, by a line to high seas point 10°48'N, 65°E, thence to high seas point 10°48'N, 60°15'E, thence to high seas point 6°45'S, 48°45'E; and

(d) on the southwest, by the Somalia border at 1°40'S, 41°34'E, to high seas point at 6°45'S, 48°45'E.




Excluded Areas (G), (H)(a), (O), (R), (S), (T), (Z), (BB) and (CC) :
In respect of **Blocking and Trapping** cover, where a vessel
navigates within any of the above Excluded Areas, the **maximum
indemnity period** shall be **limited to 90 days** in respect of **any
one casualty/incident, in the aggregate.**


(H) (b) Saudi Arabia (Red Sea coast) excluding transits
This exclusion shall not apply where the vessels or craft are transiting the water claimed by Saudi Arabia as the territorial waters as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer cargo, stores, personnel or the like.

(K) Yemen
This exclusion shall not apply where the vessels or craft are transiting the water claimed by Yemen as the territorial waters as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer cargo, stores, personnel or the like.

(L) Eritrea
This exclusion shall only apply South of 18°N

(U) Cabo Delgado (Northern area of Mozambique and Southern area of Tanzania)
The territorial sea of Mozambique and Tanzania enclosed by the following boundaries:
a) To the north, from Mnazi Bay at 10°19.6'S, 40°18.9'E to high seas point at 10° 10.3' S, 40° 34.44' E
b) To the south, from Baía do Lúrio at 13°30'S, 40°31.6'E to high seas point 13° 29.97' S, 40° 49.7' E.

(N) Venezuela
· including all offshore installations located within its Exclusive Economic Zone, which is deemed to extend 200 nautical miles from the coast of mainland Venezuela.
But this area;
(i) shall not include any installations in the above area which are in the territorial waters, out to 12 nautical miles, of Islands, Dependencies or Countries which are not owned by Venezuela.
(ii) shall not apply where the vessels or craft transiting Venezuelan waters as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer of cargo, stores, personnel or the like.

· It is understood and agreed that the vessel calls to Venezuela other than Lake Maracaibo & Gulf of Venezuela South of 11° North without giving notice of the voyage (except for B&T). However, this dispensation may be cancelled by insurer with 3 working days notice.

(Y) Guyana
Calls to Offshore Installations in the Guyanese EEZ beyond territorial waters only.

•1) Sea of Azov and Black Sea waters enclosed by the following boundaries

- a) On the west, around Romanian waters, from the Ukraine-Romania border at 45° 10.858'N, 29° 45.929'E to high seas point 45° 11.235'N, 29° 51.140'E
- b) thence to high seas point 45° 11.474'N, 29° 59.563'E and on to high seas point 45° 5.354'N, 30° 2.408'E
- c) thence to high seas point 44° 46.625'N, 30° 58.722'E and on to high seas point 44° 44.244'N, 31° 10.497'E
- d) thence to high seas point 44° 2.877'N, 31° 24.602'E and on to high seas point 43° 27.091'N, 31° 19.954'E
- e) and then east to the Russia-Georgia border at 43° 23.126'N, 40° 0.599'E

•2) All inland waters of Ukraine, including inland waters within Crimea and other Ukrainian territories under Russian control

•3) Inland waters of Russia within the following areas:

- a. River Don, from Sea of Azov to vertical line at 41° E
- b. River Donets, from River Don to Ukraine border

•4) All inland waters of Belarus south of horizontal line at 52° 30' N

including the Chishima Islands (Kuril Islands) claimed by Russia.

This exclusion shall not apply where the vessels or craft which are transiting the waters of the Sōya Strait and/or the waters surrounding the Kuril Islands, less than 12 nautical miles offshore of islands claimed by Russia as long as whilst transiting, such vessels or craft shall not call at any port or place or interrupt their passage to engage in the transfer of cargo, stores, personnel or the like.
